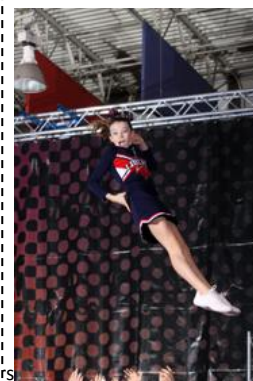

AGE CRITERIA:

If you are 18 years old or younger as of 8/31/12 you are eligible to be on a team. It does not matter what grade you are in, or if you have graduated. USASF rules go only by age (**Minimum age of 5 years old**).

CRITERIA:

Candidates will be placed on teams based on these skills:

STUNTS: Cheerleaders will be put into stunt groups and placed on an appropriate team based on technique, strength, and how much they "fight" for the success of the stunt.

JUMP: They'll be evaluated on their toe touch, pike, and front hurdler.

DANCE: Coordination, rhythm, accuracy, facials/enthusiasm.

TUMBLING: (**Tumbling skills are NOT required, but are desired.**)

Tuition Payment and Billing Policies:

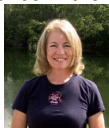
I understand if the participant is enrolled in a program that has installment monthly tuition I am continuously enrolled in the program and I will incur installment monthly tuition charges on my account until I submit a Stars & Stripes class [drop request](#). This document may be obtained from the Stars & Stripes Business Office or downloaded from our website www.StarsAndStripesKids.com. If I am dropping a class (with installment monthly tuition) it must be done on or before the last day of the month. If I drop a class after the month begins I will not receive credits and/or refunds for the remaining classes in the current month. I understand that Stars & Stripes does not give make-up classes, credit and/or refunds for, but not limited to programs, class(es), inflatable's, gymnastics, tumbling, cheerleading, clinics, camps, private lessons, birthday parties, birthday party guests, bring a friend, play time, field trips, special olympics, swimming, competitions, preschool, group activities, family fun nights, parents night out, trampoline, dance, karate, circuit training, running, free weights, conditioning, obstacle courses, personal training and group fitness, missed and/or cancelled due to holiday, vacation, illness, weather or any other reason. Stars & Stripes does not issue refunds. All sales are final for any product and/or service purchased and/or provided by Stars & Stripes. Contingent on availability Stars & Stripes may issue a free pass to an open gym for a missed class. If you should receive five classes during the month instead of four there will be no extra charge although it will be considered a make-up for classes missed while we are closed for holidays. We've found that during the course of a year this averages out nicely and is a far less confusing payment arrangement for everyone concerned. You are responsible to make timely payments of balances due on your Stars & Stripes account. From the date of registration forward your entire account balance shall be due the 1st of each month. You understand this only applies to programs that have installment monthly tuition. Fees for other products and/or services shall be paid for at the time of purchase and/or registration. If your payment is not received on or before the due date, Stars & Stripes will initiate electronic payments for any balances due on your account PLUS an administrative late fee of \$25.00. Payments will be processed with the payment method/information you have chosen on the [registration form](#) that is kept on-file with Stars & Stripes. If provided, an e-mail notification will be sent any time a payment is processed. You acknowledge that this authorization will remain in effect until you notify the Stars & Stripes Business Office in writing that the authorization should be terminated. If for whatever reason, payments cannot be processed and your account balance remains overdue, understand that enrollment in classes will be cancelled. You will be responsible for all costs incurred for collection of any delinquent payments, including but not limited to collection/ attorney fees/ court costs. You understand that monthly payment amounts may vary as classes are added or dropped and as other charges/payments are applied to your account. A \$25.00 late/insufficient funds fee will be charged for all un-paid accounts monthly. New and updated billing, address and telephone information is the responsibility of the member, and not the responsibility of Stars & Stripes to notify the member of expired/declined credit cards and EFT returns. All overdue accounts, including cancelled accounts, will be charged \$25.00 late fee each month until the account is paid in full or arrangements are made for payment. All currently enrolled students will be charged an annual registration fee of \$35 (one child) or \$50 (family) that will be posted to my account on the 1st of the month of my registration anniversary date with Stars & Stripes. Stars & Stripes reserves the right to modify the terms of this agreement with written notice.

Attendance:

MANDATORY – no medical appointments, family babysitting, family in town, don't "feel good" etc. Remember that other team members have driven great distances and paid money for each practice. One person missing means that an entire group of girls is unable to practice their stunts and that is extremely frustrating, especially when we only practice a few times a week. If a girl has a fever or is vomiting and does have to miss practice, her **parent** must call the coach ASAP so the practice agenda can be adjusted.

Contact with Your Childs Coach:

If your child will be missing practice, please leave a message for the coach by calling the gym at # 248-625-3547, while listening to the main greeting—DIAL 9 for our company directory. If you are calling during office hours the Business Office Staff can direct your call. If you leave the information on the business office voicemail rather than for the individual coach, the message delivery may be delayed if the business office is closed. Practice plans often will need to be adjusted when girls are absent, so it really helps us out when we know ahead of time. If you are planning an absence in the future, send that information via email.....

Practice Clothes:

Proper practice attire includes shorts, t-shirt, cheer shoes and socks. Tops that are low-cut, have spaghetti straps, or leave the midriff bare (this includes shorts) are not permitted. Hair must be pulled back from the face, and jewelry removed. For those of you who wish to purchase clothing we will have a complete line of Liberty Cheer clothing available for purchase in the pro shop. Parents please understand if your child does not adhere to the required dress code, proper clothing will be provided to them and your account at Stars & Stripes will be billed accordingly for the merchandise purchased.

Team Camp, Choreography and Stunting Information:

Tumbling is a huge part of Cheer and if you are looking for extra tumbling instruction you should consider the tumbling camps offered this summer.

These camps are not required for the cheer teams but are strongly encouraged. You may also wish to enroll in a Tumbling Class or Skill Clinic. Class offerings can be found on our website: www.StarsandStripesKids.com.

Tumble 1 is specifically structured for the beginning tumbler. Students will learn proper stretching techniques with an emphasis on shoulder flexibility, necessary strength training exercises and core tumbling skills including a bridge, handstand, cartwheel and rolls. Skills learned in this class will provide a strong base for continued progression.

Tumble 2 is the second level of the tumbling program. Tumblers will be expected to have a moderate level of flexibility and mastery of beginning skills. They will continue to work on improving strength, flexibility and progressing on to such skills as round-offs, front limbers & back walkovers.

Tumble 3 is offered for tumblers to improve their intermediate level skills while learning advanced tumbling skills. Tumblers will safely learn skills such as back handsprings, round-off back handsprings and front walkovers, using effective drills & training tools.

The Advanced Tumbling class is designed for tumblers to learn and progress their running tumbling passes. A solid round-off back handspring is required to participate. Tumblers will have the opportunity to take their tumbling to the next level with knowledgeable instructors to assist gymnasts in enhancing their strong elements. Tumblers will work on back handspring series, back tucks and advanced running tumbling combinations.

Fee Schedule for Season:

If you are signed up for auto billing your balance will be processed automatically. If you are not on auto billing and payment is not received on or before the due date, your credit information on file will be drafted for the balance due.

We have taken the costs for the season (ex. music, choreography, competition fees, etc.) and devised a plan that has been working well for many years. We will bill ONE lump sum payment of \$299 April 1st and the remaining fees will be divided in \$89 installments each month of the season (April-March). It is necessary to charge the initial upfront fee as we are required to pre register the teams and pay our entry, choreography and music fees several months prior to the actual date of the events. We have taken the expenses of the season and subtracted the \$299 initial payment and divided the remaining balance into \$89 installment payments.
